Responsibilities:

Support Business As Usual Activities

Client Onboarding

- Support client onboarding activities that involve the validation and transformation of plan member data to map to and adhere to system requirements, execution of User Acceptance Testing and production data validation, and peer review of onboarding files by other team members.

Monthly Payroll

- Support payroll activities through variance analysis and reconciliation of monthly payroll reports and preparation of reconciliation reports for pension plan sponsors/administrators, reinsurers and other insurers.

Annuity Administration

- Assist with ongoing annuity administration such as investigating and resolving claims related queries from plan sponsors, administrators, reinsurers and/other insurers, validation of monthly reports and delivery of ad-hoc requests for member data and/or reports.
- Support third party data related initiatives, i.e., tracing exercises, review of tax slips etc.

Project Lead

- Represent the group annuity operations team in major projects, business and technology transformation initiatives to enhance the group annuity life cycle processes.
- Lead initiatives related to business process reengineering, system enhancements and legislative changes.
- Provide leadership and technical guidance to other team members.
- Identify opportunities where existing business processes can be streamlined or reengineered and lead the design and implementation of those changes.
- Communicate group annuity operations requirements to vendors engaged for project work; including the development of process documentation, and provide support throughout the development life cycle, i.e., UAT testing.
- For projects involving third parties, develop testing plan, from planning through to development, training and post deployment support.
- Lead the development and delivery of cross training with team members and provide expertise and knowledge transfer on business processes.
